

## RELEVANT INFORMATION FOR NEW ZEALAND VISA APPLICANTS

*Please read CAREFULLY all the information contained in this document. Once read and understood, please complete the web form found [here](#). Make sure you have filled out ALL the fields and have done so using the PASSPORT with which you are applying for your Visa. Once the online form is completed and submitted, we will call you within 2 business days to schedule an appointment. If the 2 business days have passed, you can call us at +34 914351823 during Monday to Friday, from 09:00 to 15:00, and press extension 2.*

### AT THE TIME YOU COMPLETE THE FORM ABOVE, PLEASE HAVE THESE DOCUMENTS WITH YOU:

- *A Valid NZER/NZHR ID number (WITHOUT THIS NUMBER APPOINTMENT CANNOT BE DONE)*
- *The eMedical Referral Letter*
- *Your original passport which nationality is eligible to apply for your New Zealand Visa.*
- *Your visa subclass*
- *The visa office where you have lodged your application*

### THE DAY OF YOUR MEDICAL APPOINTMENT PLEASE BRING WITH YOU:

- ***Every original document above**, you already had before the appointment,*
- *Relevant and updated Medical Documents, mainly if you are under chronic medication or suffer from chronic diseases. (Copies of GP and/or specialist reports, if available, for any significant medical conditions).*
- *Spectacles or contact lenses if you wear them.*
- *Children and candidates under the age of 18, must come to the appointment with their parents or legal representatives, and with their respective passports. Legal representatives must present also their legal documents which entitle the representation.*

## TYPES OF VISA.

- A. *Permanent VISA*
- B. *Temporary VISA*

### A. PERMANENT & TEMPORARY IMMIGRATION VISA FOR CHILDREN UNDER THE AGE OF 5.

- *A Medical check-up will be performed.*
- *An IGRA Test may be required (plus 175€)*
- *COVID Vaccine. If vaccinated, under consent, the registry of every shot.*
- *DNA Test. Only if requested by the New Zealand Department of Foreign Affairs.*
- *It costs 125 Euro (excluding plus above).*

### B. PERMANENT & TEMPORARY IMMIGRATION VISA FOR CHILDREN BETWEEN THE AGES OF 5 and 10 years of age.

- *A Medical check-up will be performed.*
- *COVID Vaccine. If vaccinated, under consent, the registry of every shot.*
- *DNA Test. Only if requested by the New Zealand Department of Foreign Affairs.*
- *It costs 125 Euro.*

### C. PERMANENT & TEMPORARY IMMIGRATION VISA FOR CHILDREN OF 11 and 14 years of age.

- *A Medical check-up will be performed.*
- *The medical itself involves a physical examination, where the applicant will undress to underwear whilst wearing a gown.*
- *Female applicants may request a female nurse to be present during the physical examination. The examination does not involve a breast or pelvic examination.*
- *Chest x-ray. It will be performed on the same day of the examination, at the Doctores Sales clinic (Calle de Núñez de Balboa, 88, 28006 Madrid), after the medical examination and without prior appointment.*
- *Though pregnant, chest x-ray is expected to be performed. It is important that you tell the Doctor at the Medical Check Up if you are pregnant, or if you think that you could be.*
- *COVID Vaccine. If vaccinated, under consent, the registry of every shot.*

- *DNA Test. Only if requested by the New Zealand Immigration Authority.*
- *Urine test sample.*
- *It costs 215 Euro.*

**D. PERMANENT & TEMPORARY IMMIGRATION VISA FOR CANDIDATES OF 15 years of age and above.**

- *A Medical check-up will be performed.*
- *The medical itself involves a physical examination, where the applicant will undress to underwear whilst wearing a gown.*
- *Female applicants may request a female nurse to be present during the physical examination. The examination does not involve a breast or pelvic examination.*
- *Chest x-ray. It will be performed on the same day of the examination, at the Doctores Sales clinic (Calle de Núñez de Balboa, 88, 28006 Madrid), after the medical examination and without prior appointment.*
- *Though pregnant, chest x-ray is expected to be performed. It is important that you tell the Doctor at the Medical Check Up if you are pregnant, or if you think that you could be.*
- *eGFR and serum creatinine (blood tests).*
- *COVID Vaccine. If vaccinated, under consent, the registry of every shot.*
- *DNA Test. Only if requested by the New Zealand Immigration Authority.*
- *Blood tests for HIV status. (only if Permanent VISA is applied plus 20 €)*
- *All doctors, dentists or nurses working in healthcare will require blood tests for HIV, Hepatitis B and C. (plus 60 €)*
- *Urine test sample.*
- *It costs 300 Euro (excluding pluses above).*

*Most cases of New Zealand visas would fall on the 4 aforementioned Status we described.*

*Nevertheless, the New Zealand Immigration Authority MAY require different exams and tests. For those cases, we state below the Individual prices:*

*CONSULTATION Ages 0 to 14: 125€*

*CONSULTATION Ages 15 and above: 180€*

*TB QUANTIFERON GOLD: 175€.*

*HEPATITIS B AND C: 40€.*

*HIV: 20€.*

*CREATININE AND EGFR: 30€.*

*X-RAY: 90€.*

*Test for HIV Cases:*

*Permanent visa applicants aged 15 years or older* *Yes*

*Non-migrating relatives of Permanent visa applicants, aged 15 years or older, if requested by the visa officer to undertake medicals* *Yes*

*Children who have been, or are to be, adopted by New Zealand citizens or permanent residents* *Yes*

*Unaccompanied Minor Refugee Children* *Yes*

*Children aged 14 years of age and younger with clinical suspicion for HIV infection, or have a history of blood transfusions or haemophilia, or if the mother is HIV-seropositive.* *Yes*

*Temporary Entry Applicants with clinical signs of AIDS* *Yes*

*All applicants who intend to work as, or study to be a physician, nurse, ambulance paramedic or dentist* *Yes*

*Persons known or found to be infected with Hepatitis C or HIV* *Yes*

*Persons where there is evidence of previous or current intravenous drug use* *Yes*

*Persons where active TB is diagnosed*

*Yes*

***THE MEDICAL EXAMINATION IS VALID FOR A PERIOD OF 6 MONTHS.***

*Public Health Risk Screening*

*Permanent visa holders who were granted a visa outside of New Zealand may be required to enter New Zealand before a first entry date (FED), based on the expiry date of the visa holder's health clearance.*

*If the visa holder has not entered New Zealand prior to their FED and the health clearance has expired, they may be requested to do the medical check up again.*

**WHEELCHAIR:**

*Please let us know on your call for the appointment, that you use a wheelchair so as to coordinate all the process on only one site (Radiology Clinic, Dres Sales).*
